Robert, now retired, has 14 years of Board experience in legal and governance. Among the institutions and companies he worked for are the Royal Navy, the Port of London Authority, and Clyde & Co, a top 20 international commercial law firm. Robert is a member of Middle Temple and of the Royal Institution for Navigation. From 2014-20 Robert was a non-executive director of Harwich Haven Authority, with special responsibility for audit and risk management.

Robert lives in Dorset and is Chairman of the East Dorset branch of the SDGR.

She brings HR experience and a commercial/market-focused perspective and over five years' experience of being on the CCCBR.

Much of his early ringing was with the University of London Society, before he moved to Cambridge in the 1980s. He has rung peals on most numbers of bells from six to eighteen. He is now tower captain at a six bell tower where he is teaching a new band using the Learning the Ropes scheme.

After working for the civil service most of Gareth's career was spent in education, first as a primary school teacher and latterly delivering in-service teacher training on the use of digital systems and resources. He has served as governor and trustee for a number of schools and a multi-academy trust.

Since retiring he has completed a history PhD on ringing in Cambridge in the eighteenth and nineteenth century. He regularly gives talks to both ringing and non-ringing audiences. He is a contributor of articles to The Ringing World and a member of the CCCBR History & Ar-chives working group. He is currently writing a history of the Cambridge Youths to coincide with the society's 300<sup>th</sup> anniversary in 2024.

A recent survey showed that history is amongst the most popular topics for Ringing World subscribers. Gareth hopes that his experience will help with the development of publications in that area, as well as contributing to the developing use of technology.
