Please note that whilst they must be proposed and seconded by representatives of one or more affiliated societies, nominees themselves need not be existing Council Members.

2. Nominations are also invited for election of one or two **Independent Examiners**. In accordance with Standing Order C7.2, nominations should likewise reach the Secretary no later than **26th July 2025***. Please note that in accordance with Standing Order F4.1 an Independent Examiner need not be a Council Member.

3. Notices of Motion for consideration at the meeting, with the names of a proposer and seconder (each being a **Council Member**), together with any supporting statements (Standing Order C2.1), also must reach the Secretary by **26th July 2025*.** Please note that all Council Members, including representatives of registered small societies and ex-officio members, are welcome to propose or second notices of motion.

4. The meeting will also receive and consider the Annual Report of the Trustees and Accounts for 2024, and the Annual Report of the Executive for 2024/25 and its Forward Plan and Indicative Budget for 2025/26.
