Gareth has been ringing both tower bells and handbells since the 1970s. Much of his early ringing was with the University of London Society, before he moved to Cambridge in the 1980s. He has rung peals on most numbers of bells from six to eighteen. He is now tower captain at a six bell tower where he is teaching a new band using the Learning the Ropes scheme.

After working for the civil service most of Gareth's career was spent in education, first as a primary school teacher and latterly delivering in-service teacher training on the use of digital systems and resources. He has served as governor and trustee for a number of schools and a multi-academy trust.

Since retiring he has completed a history PhD on ringing in Cambridge in the eighteenth and nineteenth century. He regularly gives talks to both ringing and non-ringing audiences. He is

a contributor of articles to *The Ringing World* and a member of the CCCBR History & Archives working group. He is the author of *Foolish Youths and Substantial Rewards: a social history of bellringing in Cambridge*, written to coincide with the Cambridge Youths' 300<sup>th</sup> anniversary in 2024.

A recent survey showed that history is amongst the most popular topics for Ringing World subscribers. Gareth hopes that his experience will help with the development of publications in that area, as well as contributing to the developing use of technology.
